2013 HUANGLONGBING (CITRUS GREENING) PROFICIENCY TEST FOR CERTIFICATION

The 2013 Proficiency Test (PT) panel for certification diagnosticians/labs conducting molecular identification of the pathogen causing Huanglongbing (HLB), also known as Citrus Greening, in regulatory samples is being prepared. There are two differences to note concerning 2013 PT and testing: 1) The current Work Instruction for screening testing of HLB (WI-B-T-D-2) has been revised to combine Candidatus Liberibacter asiaticus and L. americanus tests into a single multiplex reaction. This WI can be accessed by registration to the CPHST-Beltsville Work Instruction document website (www.nahln.org). A separate WI for processing and testing of the PT panel samples will be provided to all participants during PT distribution. The associated WIs for DNA extraction of plant tissue samples for the PT and for USDA regulatory samples are currently unchanged. 2) HLB 2013 PT distribution will occur from mid-November 2013 through February 2014.

The USDA HLB PT program began in 2007 in support of PPQ Citrus Health Response Program. Like the earlier years, the 2013 HLB PT panel consists of DNA samples requiring PCR analysis and lyophilized tissue samples requiring DNA extraction and PCR analysis. Participating laboratories should possess a

valid USDA permit for interstate diagnostic samples to receive the PT panel. Information and applications for permits can be viewed at the following USDA-APHIS-PPQ website: www.aphis.usda.gov/plant_health/permits/organism/index.shtml.

When sent, HLB positive and healthy DNA controls for PCR will be provided for use with each panel.

To ensure the PT panels are of sufficient quality prior to shipment, the panel samples have been extensively tested according to USDA-approved diagnostic protocols. Individual, randomly selected aliquots of each DNA panel sample are tested periodically to ensure DNA stability. DNA is also extracted from randomly selected lyophilized tissue samples at regular time intervals and tested by PCR to ensure tissue stability and uniformity.

It is suggested that primers/probes/reagents are ordered in advance so that all required reagents are on hand before panel receipt. Please be aware that fluorescent probes can take up to 14 days to receive. For those who have been previously HLB certified, it is strongly suggested that a new set of primers and probes is ordered, since degradation is one of the

major reasons for failure or low efficiency of PCR. Purchase of a new DNeasy® Plant Mini Kit (Qiagen® cat. # 69104) is strongly recommended since using expired kit components contributes to low DNA extraction efficiencies, often resulting in out-of-range real-time PCR values and faint or missing conventional PCR product bands.

Please Note: PT Work Instructions will be provided with the panel. While these PT Work Instructions use the same probes/primers and reagents as the Work Instructions for regulatory samples, the PT Work Huanglongbing (Citrus Greening) Proficiency Test 2013 National Plant Protection Laboratory Accreditation Program Page 2 of 5 Instructions include additional guidelines for handling and information specific to the processing of PT panel samples only. Likewise the PT work instructions should not be used for testing field samples.

In addition to the PT Work Instructions, results reporting forms will be provided electronically for PT results submission. Panel results submitted in an unacceptable format (other than the reporting forms provided) will be returned for reformatting and resubmission, thereby delaying the results evaluation. Upon receiving properly submitted results, panel results evaluation and prompt feedback will be provided by NPPLAP within one month.

The form to request a panel(s) can be found at the end of the 2013 Proficiency Test Letter for Huanglongbing. Each individual participant should choose a preferred month (mid-November through February) to receive a panel(s), fill out the application form and promptly return the completed form by e-mail to Vessela.A.Mavrodieva@aphis.usda.gov.

Diagnosticians or laboratories new to the PT program, should contact NPPLAP as soon as possible in order to complete the required documentation before receiving a 2013 PT panel.

Quality Corner Using the Get Started Implementation **Booklet to Establish**

the STAR-D Laboratory Accreditation System in your Laboratory; Step 3

So far we have review steps 1 and 2 of the "STAR-D: How to Get Started in Your Laboratory" booklet. Hopefully those articles were helpful and have given you a few ideas about planning for the implementation of the STAR-D laboratory accreditation quality management system in your laboratory. We understand that the idea of implementing such a complex system can be daunting. It is much easier to implement if it is broken down into manageable segments, therefore, we are continuing the review of each page within the booklet by providing this information in the NPDN News, under the STAR-D quality corner section.



Step Three builds on Step One and Two by continuing the process of preparation, assigning duties to lab members and reviewing the webpage, document templates and auditor checklists. Remember to begin this process you should set a goal for each activity in this section. When completed, post the date. Checking off each item provides a great sense of accomplishment!

Activities:

- ★ Look at example Quality Manuals to see how others interpreted the NPDN Requirements and Standards, and how they modified the Quality Manual template to suit their laboratory. We have four examples now available on-line!
- ★ Select which laboratory member will approve your document system and document changes.
- ★ Decide where you will store electronic versions of your documents. Be sure to choose a place easily accessible by laboratory staff.
- ★ Write your Quality Manual. (This is a big step into implementing your STAR-D program!) Look over

- QP, WI and Form templates, that pertain to section 4.3 Documents, decide which you will use.
- ★ Create any needed document related QPs, WIs and Forms.

Step Three includes a Helpful Hints section. The hints are a collection of items gathered from a few of the diagnosticians that have started this process. They provided their most helpful messages for you. All you need to do here is review the hints, think about if any of the hints pertain to you or your laboratory and if you like one of the provided hints, discuss it with your laboratory members.

Helpful Hints:

- ★ If you currently have tools that work effectively, keep them. If you already have documents that are effective, add a unique identifier.
- ★ Not every procedure needs to be written down.
- ★ When writing your documents, give yourself lots of flexibility. Do not say "Use a No. 2 pencil" when a pen will not change the results of the test.
- ★ You will not always need all levels of documentation for every section. Some sections will be completely covered in your Quality Manual (QM), others may be introduced in the QM and specifics given in a QP, and others will need the QM, QP, WI and Forms.
- ★ Include version numbers on each document. Small changes should increase by tenths; big changes may warrant a whole number increase.

2014 NPDN/USDA-APHIS Advanced **Diagnostic Workshops**

The NPDN Diagnostics Program Area Committee and members of USDA-APHIS-PPQ-CHPST-National Plant Germplasm and Biotechnology Laboratory (NPGBL) are pleased to announce the 2014 advanced diagnostic workshops. The workshops will begin on March 4, 2014 and a number of topics will be covered. We have planned the workshops in consecutive weeks again this year so that the Beltsville staff can

focus on these sessions during this four week period and then devote the rest of the year to other activities. This format seemed to work well for all those involved last year. During the spring of 2014, we will again offer advanced trainings on a number of topics.

Week 1: Bioinformatics, March 4-6, 2014

In previous years we have offered this session in two parts. Beginning last year, the two parts were combined which made this a 3 day workshop that included detailed guidance on sequencing PCR amplified fragments either directly or after cloning. The rest of the session will cover analysis of obtained sequences from both plus and minus strands, editing sequences, blasting sequences, understanding blast results based on size and gene target, when to directly sequence PCR products or clones, which genes are used for sequence analysis for fungi, bacteria, and viruses, what sequence analysis programs are available commercially or as freeware, and hands-on use of sequence analysis programs using sequences from case studies for different pathogen types, and allowing the participants to work with their own sequences.

Week 2: Phytophthora, March 11–14

Due to continued interest, we have scheduled a Phytophthora training session. The session is 3 ½ days long and covers ELISA, DNA extraction, conventional PCR (nested and multiplex), real-time PCR (ITS and Elicitin), and interpretation of results.

Week 3 (first pt of wk): Potato Wart, March 17–18

Again due to continued interest, we have scheduled a Potato Wart session. The session is 2 days long and will be held the first part of the week with Citrus Greening-HLB at the end of the same week. Those interested in both topics may want to choose this option to complete both sessions with one trip.

Week 3 (second pt of wk): Citrus Greening-HLB, March 19-21

Due to the continued presence and spread, there continues to be a need for Citrus Greening-HLB training. This session will be done over a 3 day period.

2014 Advanced Diagnostic Workshops

Week 1: Bioinformatics, March 4-6, 3 days

Week 2: Phytophthora, March 11–14, 3.5 days

Week 3 (1st pt of wk): Potato Wart, March 17-18, 2 days

Week 3 (2nd pt of wk): Citrus Greening-HLB, March 19–21, 3 days

Week 4: Citrus pathogens, March 25–28, 4 days

Week 4: Citrus pathogens, March 19–22

This topic was very popular over the past two years that it has been offered. The 4 day session will cover citrus leprosis, sweet orange scab and citrus black spot in a $4\frac{1}{2}$ day session. The training will cover disease symptoms and methods of detection and identification of CiLV, CBS and SOS. The molecular diagnostics will include PCR, real-time PCR, RT-PCR and RT-realtime PCR. This workshop completes the schedule of advanced diagnostic workshops at Beltsville for 2014.

Week 5: Citrus Greening-HLB, March 26–28

Due to the continued presence and spread, there to continues to be a need for HLB training. This session will be done over a 3 day period and will conclude our training for the year.

More specifics about travel and lodging will be sent directly to participants before the end of December so that they can make their travel plans. Expenses for travel, lodging and meals will be covered from a supplemental grant for diagnostician training so you will not need to use your funds from this year's NPDN allocation. All expenses will be processed through Cornell University. There is no registration charge for the workshops or for meeting materials. These expenses are covered by our colleagues at the CPHST Beltsville Laboratory. Funds for reimbursement of travel expenses are limited. Priority will be given on a first come, first served basis in order by requests received until funds are exhausted. Please sign-up as soon as possible to ensure your spot in the workshop and your expense coverage! ITP and QBIT Release Lucid Mobile Apps for Android



The internationally recognized Lucid software for developing matrix-based identification keys to biological organisms has recently added support for Lucid keys on mobile devices. You can now carry Lucid keys with you into the field on your mobile devices without requiring internet access. Lucid Mobile takes full advantage of all the conventions and functionalities you have grown accustomed to on your mobile device, while supporting the features you value in desktop Lucid keys.

The Identification Technology Program (USDA-APHIS-ITP) announces the first release of Lucid Mobile apps to support plant pest identification for Android smartphones and tablets. Developed in cooperation with The University of Queensland's QAAFI Biological Information Technology team (QBIT), the 10 apps are now available for download, at no cost, from Google Play USDA APHIS ITP. The 10 Lucid Mobile apps will be available, via the Apple iTunes website, in early 2014.

For the first suite of Lucid Mobile apps, ITP and QBIT selected desktop Lucid keys from ITP's existing tools (http://idtools.org), that had potential value, if converted into Lucid Mobile, to support field pest screening and identification.

The Lucid Builder software allows taxonomists, agronomists, and other developers to combine their expert knowledge with multimedia and an easy to use interface to produce identification and diagnostic tools for use by a broad range of users. Previously, access to these Lucid keys has been via a CD, a DVD, or online. Now, Lucid Mobile provides a more readily accessible means of accessing Lucid keys – via mobile phones and tablets. The release of Lucid Mobile means that existing or new Lucid keys can now be converted to an easy to use and intuitive app, allowing identification and diagnostic knowledge and expertise to be carried around in your pocket and opens up the possibility for in-field identification and diagnostic support without requiring an internet connection. Lucid Mobile supports both Android and iOS platforms – each Lucid Mobile app is packaged as a free or commercial stand-alone product, ready for download from Google Play Store or Apple iTunes.

Overall Confidence Levels in National Repository

There are a total of four confidence levels that can be applied to a pest/pathogen in the National Repository which consist of Confirmed, Not Detected, Suspected, and Inconclusive. Defintions for each of the levels are provided below and can also be found in a December 2010 newsletter article.

Terms and Definitions

Confirmed — the diagnosis was derived using approved molecular technologies, serological testing and/or morphological observations which

allowed for the confirmation of the organism to Genus, species and/or race or pathovar level.

Not Detected — the sample was submitted as a suspect sample or as part of survey project. The pathogen was not detected on this sample at this time using approved molecular technologies, serological testing and/or morphological observations.

Suspected — diagnostic symptoms of the pathogen were present but evidence of the pathogen could not be confirmed at this time. This term may also be used at the species level if confirmations cannot be made. This term may also be used with abiotic entries.

Inconclusive — although a suitable sample was received, a reliable result could not be achieved. For example, the test kit may have not worked correctly and there was no sample material remaining to perform the test again. Or, no DNA was detected in a PCR analysis. Inhibitors may have been present in the sample. A second attempt may have been made with the same results. The only conclusion is to label the sample as inconclusive.

Overall Confidence

During data entry confirmation levels are provided for the genus, species, and sub-species if populated. How these entries get translated into an overall confidence level is dependent upon the type of pest/pathogen that is selected. The matrix shown in Figure 1 covers three different scenarios and illustrates the impact each can have on the overall confidence level. The highlighted cells emphasize the confidence level that determines the overall confidence.

The first scenario uses *Phytophthora* sp./spp. as the pest. For all pest entries that have sp./spp. as the species the overall confidence level will only go to the genus level. There are some lab management systems that will send in an Inconlusive confidence for the species, however, it doesn't matter what confidence level is entered for the species because the overall confidence will only report out to the genus level as demonstrated in the first four rows in the matrix. The second scenario is *Phytophthora* ramorum where the confidence level of Not Detected is entered for the genus. In this case, it does not matter what confidence is entered for the species, the overall confidence will always get reported as Not Detected as demonstrated in rows 5-8 in the matrix. The final scenario is for *Phytophthora ramorum* where the genus confidence level is Confirmed. In these cases the overall confidence level will be based on the species or sub-species if it is populated as shown in rows 9–12 in the matrix. This scenario also holds true for entries where the genus confirmation level is Suspected or Inconclusive.

USDA Announces the Grand Opening of Atlanta's New Plant Inspection Station

On November 7, APHIS announced the grand opening of Atlanta's newly-expanded plant inspection station.

"To keep up with the increasing volume of fresh cut flowers and live plants imported into the United States, APHIS' Plant Protection and Quarantine (PPQ) program has built a state-of-the-art hub," said Osama El-Lissy, Deputy Administrator of PPQ. "This expansion will expedite shipment processing by allowing for the simultaneous inspection of multiple shipments, making it just one example of USDA's overall effort to facilitate and expand trade with our partners worldwide."

Features of the new plant inspection station include an operations control center to ensure the safety of entering agricultural products, water saving and energy conservation fixtures, and laboratories and inspection rooms that exceed current engineering and safety requirements.

Since 2005, plant cargo into Atlanta has increased from fewer than 4 million plant imports to more than 200 million plants.

The Atlanta Plant Inspection Station, established in 2005, is one of 16 such facilities located at major ports of entry across the United States. It is currently the nation's second-busiest point of entry (behind Miami) for foreign-grown flowers, ornamental shrubs, and

other plant material. Since 2005, plant cargo into Atlanta has increased from fewer than 4 million plant imports to more than 200 million plants.

In today's global marketplace, the volume of international trade brings increased potential for the introduction of foreign pests, diseases, and noxious weeds that could threaten American agriculture and natural resources. The results of such introductions can have a devastating effect on the U.S. food supply and cost hundreds of millions of dollars in eradication and control measures. This ultimately can result in higher priced agricultural products for the consumer. In fiscal year 2012 alone, more than 1.3 billion plants were imported into the United States. Each of these imports goes through a series of overlapping safeguarding measures prior to U.S. entry.

The Obama Administration, with Agriculture Secretary Vilsack's leadership, has aggressively worked to expand export opportunities and reduce barriers to trade, helping to push agricultural exports to record levels. U.S. agriculture is currently experiencing its best period in history thanks to the productivity, resiliency, and resourcefulness of our producers and agribusinesses. Today, net farm income is at record levels while debt has been cut in half since the 1980s. Overall, American agriculture supports 1 in 12 jobs in the United States and provides American consumers with 83 percent of the food they consume. Strong agricultural exports contribute to a positive U.S. trade balance, create jobs, boost economic growth and support President Obama's National Export Initiative goal of doubling all U.S. exports by the end of 2014.
